Handwashing sinks are properly equipped with hand soap, individual disposable towels or hand drying device, and signage; and conveniently located.</p>
<p>Violation #49. Non-food contact surfaces clean Biological growth was observed on the outer section of the walk-in refrigerator. Clean and sanitize external surface of the walk-in refrigerator. The Person in Charge had the external surfaces of the walk-in refrigerator cleaned and sanitized. Corrected on Site.</p> <p>CODE REFERENCE: 64E-11.003(4). Non-food contact surfaces shall be kept clean and free of an accumulation of dust, dirt, food residue, and other debris.</p>
<p>Violation #55. Facilities installed, maintained, &amp; clean Nonfunctional three-door reach in freezer PC#1006310. Repair/replace freezer. Work orders submitted on 04/16/21 &amp; 04/26/21. Work order #4183020 &amp; 4185115 respectively. Signage dated 04/16/21 posted on the unit indicating that repair was in progress, and that a compressor was on order.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
<p>Violation #56. Ventilation &amp; lighting Dirty HVAC vents located above the serving line. Clean and disinfect vents.</p> <p>CODE REFERENCE: 64E-11.003(6)(a).
